The district court made the following findings of fact. Officer Dykes asked Smith to step out of the car. Dykes noticed a plastic bag in Smith's coat pocket. Dykes asked for and received permission to search Smith. Dykes searched the bag and found a loaded revolver. 3 The parties stipulated that Smith had a prior felony conviction and that the firearm had traveled in interstate commerce.
